New Mexico performances to add %7.3125 Sales Tax. Included in price for event, Vanilla Pop will provide:

- Background music on IPod during cocktails and/or dinner (If both are taking place in same room as performance.)
   Client may provide his/her own IPod with their own music for this purpose.
- Microphone(s) available for toasts and/or speeches.

IF PURCHASER WISHES BAND TO LEARN NEW MUSIC FOR EVENT, FEES ARE AS FOLLOWS:

- 1 SONG: \$250.002 SONGS: \$500.00
- 100 SONGS \$1,000,000.00

#### FOR All PERFORMANCES:

- A performance area of at least 15' Wide X 12' Deep.
   If a stage is to be used- please request our "RISER.PDF".
- 2. Adequate dancing room in front of the band. (We love the dancers but hate it when they fall on our stuff.)
- 3. If a stage <u>and</u> dance floor are to be set up, please **LEAVE A SPACE OF 3 FEET** between the dance floor and the front of the stage or performing area. This is to accommodate our speakers so that they are not on the dance floor restricting your guests.
- 4. ONE SEPARATE DEDICATED 20 AMP CIRCUIT FOR BAND USE ONLY. (Please have the electrician for the venue add a dedicated power drop if no separate circuit is available.) This will allow proper functioning of equipment. Faulty power can create delays for which the band is not responsible. Tracking down tripped breakers and restoring power will be part of 2.5 hour engagement.
- 5. One meal per band member. (2 total, sometimes 3 if our roadie is in tow). If there is a bar or cafe on premises we prefer to eat there to accommodate our tight setup, eating and performance timeline. Please NO vendor meals or venue cafeteria vouchers.

### A green (dressing) room FOR BAND USE ONLY supplied with:

- Several bottle of water for the night. Please have these available upon our arrival.
- One (1) bottle of Tito's vodka or other national brand, one (1) bucket of ice, & four (4) glasses. Or if this is against venue policy...full bar privileges for the length of the show.
- Access to running water / mirror

# IF PLANNING AN OUTDOOR PERFORMANCE, IN ADDITION TO THE ABOVE THE FOLLOWING <u>MUST</u> BE PROVIDED:

- 1. A covered (and we mean **FULLY COVERED**) space of no less than 20' x 20' **with drop down sides**. Drop down sides are not necessary for large open air **covered** spaces larger than 20'x20', as long as the band is set up **at least 15'** in from the back of the performance space.
- 2. A level stage on level area of at least 15' wide x 12' deep. We will not perform on grass, bare gravel sand or any other surface which is porous and not 100% stable.
- 3. An adequate electric source (2 separate 20 amp circuits at 115 volts grounded), on stage **FOR BAND USE ONLY**. This will allow proper functioning of equipment. Faulty power can create malfunctions & delays for which the band is not responsible.
- 4. Outdoor temperature must be at least 60°.
- 5. There is a \$200.00 equipment moving fee if the need arises during an outdoor engagement. Moving time will be part of 2.5 hour engagement.

The above requests are for your benefit as well as ours.

We are a very visual and performance oriented show. If problems arise during the performance, it is usually due to inclement weather or loss of power which inevitably results in delays and an angry mob.

We want you and your guests to come away from your event with a long lasting sense of inner peace, harmony and tranquility, as well as some wonderful memories of a great party.
